



Population - Retrospective Year View




Total Agent Workload - Retrospective Year View









Number of Detainees and % of Population












State Sentence Additions




- The Eastern Region's previous six-month average number of state sentence additions is 285. March 2007 amount is 14% greater than the previous six-month average.
- In March 2007, the Eastern Region accounted for 38% of the statewide total of 864 state sentence additions.

Number of Absconders and Detainees



- In March 2007, the 785 absconders represented a decrease of 3% below the previous six-month average of 813, and the 2,618 detainees represented a decrease of 1% below the previous six-month average of 2,633.
- The Eastern Region accounted for 51% of the 1,536 statewide absconders and 41% of the 6,328 statewide detainees in March 2007.

Number Employed and Employment Rate*



- The March 2007 employment rate was two percentage points less than the previous six-month average of 61%.
- The number of employed parolees in March 2007 was 3% less than the previous six-month average of 4,008.

State Sentence Parole Revocations



- The Eastern Region accounted for 39% of the 427 statewide state sentence parole violator revocation field case closures in March 2007.
- The 167 Eastern Region state sentence parole violators in March 2007 consisted of 53 convicted parole violators (32%) and 114 technical parole violators (68%).






- The Central Region's previous six-month average number of state sentence additions is 285. March 2007 amount is 15% greater than the previous six-month average.
- In March 2007, the Central Region accounted for 38% of the statewide total of 864 state sentence additions.

- The March 2007 employment rate was one percentage point less than the previous six-month average of 75%.
- The number of employed parolees in March 2007 was 1% less than the previous six-month average of 4,529.

Number of Absconders and Detainees



- In March 2007, the 418 absconders represented a decrease of 6% below the previous six-month average of 447, and the 1,976 detainees represented a decrease of 1% below the previous six-month average of 1,988.
- The Central Region accounted for 27% of the 1,536 statewide absconders and 31% of the 6,328 statewide detainees in March 2007.

State Sentence Parole Revocations



- The Central Region accounted for 37% of the 427 statewide state sentence parole violator revocation field case closures in March 2007.
- The 160 Central Region state sentence parole violators in March 2007 consisted of 69 convicted parole violators (43%) and 91 technical parole violators (57%).





State Sentence Additions




- The Western Region's previous six-month average number of state sentence additions is 208. March 2007 amount is 1% greater than the previous six-month average.

Number Employed and Employment Rate*




- The March 2007 employment rate was one percentage point less than the previous six-month average of 71%.
